#### Tim Shaffer to Speak to Print Group

Our print night speaker on Wednesday, March 2 will be Tim Shaffer. He will speak on the "Transition from Film to Digital." Tim is a professional photographer and owns The Classic Image Studio in Fort Plain, New York.

His early education in photography was at the Germain School in New York City; this was followed by seventeen years of photographic experience in the world of publishing. He opened his studio in Fort Plain in 1990 where he specialiazes in weddings, high school seniors, and family photography, as well as an occasional commercial assignment.

From 1973 to 74 he worked at the Ridgewood Newspapers in Ridgewood, New

Jersey as a news photographer and chief darkroom technician.

From 1975 to 1993 he worked at Lee Publications in Palatine Bridge, New York as the chief photographer and camera room technician.

His awards include the award winning print accepted to the 2003 International Loan Collection of the PPA, the 2002 Fuji Masterpiece Award, the Theme Competition PPSNY 1998, the Court of Honor 2004 and the Highest Cumulative Print Case score 2004 PPSNY.

Tim is a member of the Professional Photographers of America, the Professional

# Warren Greene: Photography as Observation, Solitude, and Replenishment

Warren Greene often finds himself alone while shooting his nature subjects; he likes it that way. For Warren, the pursuit of images of wild birds and scenic landscapes is meditative, and it replenishes his soul.

As the Director of the Fulton County Office of Probation, Warren has a stressful job. As

his hobby, photography offers a complete change of scenery and pace. Warren has been shooting photographs regularly since 1976. While his degree in psychology most certainly helps him in his probation work, his skills in photography have been self-taught, through what he says has been a "series of trial and error." Warren says that some photographers visualize the world with a wide angle lens; others see the world with a normal focal length; Warren sees the world in telephoto.

Perhaps this vision of the world has helped Warren create the images for which he is most recognized. He is known for his autumn scenic shots, and pictures of wild orchids in the Adirondacks. However, Warren's telephoto view of the world is most apparent in his wild bird photography. His avian images have appeared in Birds & Blooms, The New York State Conservationist, and Adirondack Life magazines. In fact, Warren is so prolific in his wild bird photography that he has a library of over 300 images in Vireo, the Visual Resources for Ornithology, which is a subsidiary of the Academy of Natural Sciences. In addition, Warren's images are used by the Cornell Laboratory of Ornithology.

When asked how he captures wild birds so effectively, Warren's answer was: "with a lot of patience!" His biggest challenge is locating the correct habitat

to find the birds and animals he wishes to capture on film. Warren uses a fully manual Leica, and while he loves the clarity the optics offer, he does find difficult keeping up with those fast moving birds. Furthermore, Warren prefers slow film (Fuji

Velvia 50 ASA, or more recently, 100 ASA) for its saturation.

To make his life easier, Warren will bring props with him to his photo shoots. For example, Warren will bring branches to place in a field to capture images of meadow larks, savannah sparrows, and bobolinks. These birds will often use the branches as comfortable perches while singing during the nesting season to announce their presence. Warren prefocuses the image, and then uses a radio remote-control shutter release to snap the picture from a distance. He also uses bird feeders filled with seed to attract birds: niger seed will attract finches; and sunflower seeds will attract cardinals and blue jays. Warren places the feeders in an area with a nice background where the sun will rise in the morning. Then, he photographs the feathered visitors while hiding in a blind that he has placed at the location a few days earlier. This helps him

capture the birds in a natural state because they are accustomed to their surroundings.

Talking to Warren, you realize that it is not the technical side that draws Warren to photography. Instead, it is being in nature, alone, where he can sit down and "observe the details." In fact, Warren jokes that "he would rather be outside being eaten alive by black flies than be in a basement darkroom messing around with chemicals!" Warren says that sometimes he goes on shooting journeys with his friends, but even then he soon finds himself alone, observing the details. Occasionally, this solitude may be interrupted by the ring of his cell phone, or a squawk of a walkie-talkie from his nearby photography companions notifying him of a subject he has to shoot. However, it is clear that for Warren, photography is like Yoga or Tai Chi; it provides him with the opportunity to focus on the moment, observe his surroundings, become lost in nature, and replenish his soul.

Warren doesn't prefer to focus his energy on the marketing aspects of his hobby. Indeed, when asked if he entered contests, he tells quite a tale. Gary, a friend, asked Warren to capture some images of ducks resting in a pond so that Gary could carve their likeness out of wood. Gary had arranged for Warren to shoot several ducks whose wings had been clipped, and who were resting peacefully on a pond. Every once in a while, wild ducks would visit the pond,

and Warren would photograph them as vel Later, when viewing the images, Gary encouraged Warren to enter his work in a nationwide photography contest. Warren's aversion to contests was revealed when he told Gary to enter his photographs under Gary's name. Much to Warren's surprise, Gary called him in a panic when a woman phoned Gary and asked him for specifics on aperture and shutter speed. Why all the questions? His image of a male and female blue winged teal had come in second place! In fact, two of Warren's images, under Gary's name of course, made it into a calendar that the contest published.

The universe does have a way of working

things out, and it continues to do so in

Warren's world. While Warren prefers not to engage in entering contests, or in the marketing of his work, he has a friend whose "calling" is website design and building. Soon, Warren's friend will scan Warren's images, and then post them on two soon-to-be-launched websites: Bluebirdimages.com Adirondacknature.com. Coincidentally, a friend of that friend has a calling in marketing, and will advertise Warren's work, and then ship the printed images when they are purchased from the websites. This allows Warren to pursue his own calling: observing and capturing beautiful images of nature, in solitude, while replenishing his soul.

# How to Enter and Win Photo Contests

Part II

#### Where to Start

There are a limited number of competitions available to the amateur and part time professional photographer. Several photo magazines have monthly competitions such as *Petersen's Photographic* and *Popular Photography*. The lists of submissions are huge and the chance of being selected is quite rare. Don't get discouraged and keep submitting; you may get lucky.

My best advice to the aspiring contestant is to look at past winning photos in these magazines. Some major international competitions are: Nikon Photo Contest International (142 winners out of 42,000 photos submitted), Olympus Vision Age International Color Slide Photo Contest (125 winners out of over 13,000 submissions) and the Canon Photo contest. These are worldwide and judged in Japan. Both prints and slides are allowed. Look at the published yearbooks of winners to get an idea of what to submit. You don't have to use Nikon, Canon or Olympic cameras to compete.

Many photo companies have yearly contests. Tamron has a competition 3-4 times a year in which you can enter your images via e-mail or by submitting slides

or photographs. The only requirement is that you have to take the image with their lens. The winning photo receives a Tamron zoom lens.

There is a yearly competition called the Austrian Super Circuit in which you can enter a variety of categories and submit your images on slides to be judged in 4 judging competitions in Europe. There is a charge for entering but you will receive a colorful yearbook of all the accepted images. The winners have an opportunity to win Hasselblad cameras with all the lenses.

If you are a member of PSA there are hundreds of international photo salons throughout the United States, Europe, South America and Asia. Although there are no monetary awards, you have the opportunity to get medals and points toward PSA recognition. You can enter general, nature, photojournalism and photo-travel competitions with both slides and prints which are returned to you at the end of the presentations and judging.

All salons are juried. This means that to be accepted into the exhibition, a group of judges have to give your images an acceptance number of points or you do not get into the final judging stage. The final judging is on the "best of the best".

Every year the *Gazette* newspaper has a photo contest in July. The winners of the weekly contests get monetary awards and are also eligible for the finalist competion. All winners are published in the *Gazette*.

Yearly is the Photo Regional in which all area photographers can participate in a juried show. The show is either in Troy or Albany and over 1000 images are entered.

The Altamont Fair has an art competition in August in which you can submit your images to be judged with other forms of art. Winners receive ribbons.

#### **How to Enter**

Read and reread all instructions carefully. Make sure what is required: original slides, prints or duplicate slides.

Label carefully with your name, address, phone number plus an entry number if required. All competitions require a SASE - self addressed stamped envelope - for the return of your work. Some competions will only return slides, not prints, and some request dupes only and will not return any work sent. Winning entries require original slides and negatives which will be returned within a year.

Do not enter any competition in which originals are requested and will not be returned. Competitions in which statements "all entries become property of ..... and will not be returned or acknowledged" should not be entered. When sending your photos, pack Slides should be in carefully. transparency protectors and reinforced with heavy cardboard. Prints should be shipped between two sheets of heavy mat board. All submissions should be sent by certified first class mail, return receipt requested. This will enable you to trace your photos if lost and will show who accepted your work when delivered.

Most, if not all, bona fide competitions do not cost money to enter. Many foreign competitions request International Reply Coupons to cover return postage. These are obtained through your post office.

- \*\*The camera was a Canon 10 D, The lens was a Canon 28 135mm IS USM zoom, film was Digital, the image was hand held, the meter reading was taken from the sky then locked, recomposed and shot. Image was printed on a EPSON 2200 inkjet printer. Shot on Erie Blvd. in Schenectady, the old Alco plant.
